Notice of Race

Event: Swedish Championship for Star boat

Date: 19th – 20th of September 2020 **Organizer:** Segel Sällskapet Kaparen (SSKa)

1. Rules

- 1.1 The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS).
- 1.2 International Star Class Association rules for Star will apply
- 1.3 Boats may be required to display advertising chosen and supplied by the organizing authority. If this rule is broken, World Sailing (WS) Regulation 20.9.2 applies.
- 1.4 The competitor that is in charge on board shall follow Swedish Sailing Federations racing license regulation for competitors. This regulation applies from the year the competitor reaches the age of 13. Competitors from other countries than Sweden are exempt from this regulation.
- 1.5 Competitors shall when afloat wear personal flotation devices. This rule does not apply to short-term replacement or adjustment of clothing or personal equipment. Wet suits and dry suits are not personal flotation devices. This changes RRS 40. A boat that breaks this rule may be warned or penalized at the discretion of the protest committee. (DPI)
- 1.6 If there is a conflict between languages, the English text will take precedence.

2. Eligibility requirements

2.1 To be entitled to participate in Riksidrottsförbundets championships, each competitor must comply with WS Regulation 19.

In order to be awarded the title Swedish Champion (SM) the competitors shall be Swedish citizens or have resided in Sweden for at least six months the last twelve months before the event starts.

At championships with more than one competitor per boat, a majority of the crew (more than 50%) shall comply with the rule regarding the title Swedish Champion. If so, the entire crew will be awarded the title Swedish Champion.

Championship plaquette and titles may be awarded if six or more boats from at least three different clubs located in more than one district have crossed the finish line in one race in the championship.

- 2.2 The competitor that is in charge on board the boat shall be a member of his/her Member National Authority or one of its affiliated organisations.
- 2.3 Each participating boat shall be insured with valid third-party liability insurance.

- 2.4 Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organising authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
- 2.5 If less than 8 participants, the organization reserves the right to cancel the regatta

3. Entries

- 3.1 Entry shall be made not later than 23.00 on 12th of September through www.sailarena.se
- 3.2 The advance entry shall include the following:

- 3.3 The entry fee is 900 SEK and shall be paid through www.sailarena.se when entry is made not later than 12th of September at 23.00 hour
- 3.4 Late entry fee e.g. after 12th of September is 1200 SEK and shall be paid through www.sailarena.se
- 3.5 Last day for late entry is 18th September until 20.00 hour.
- 3.6 If there are problems for non-Swedish participants to entry via the homepage www.sailarena.se you can transfer the fee to the account of SSKa.

In this case you <u>must notify</u> the organization your entry (according to 3.2) by mail to regatta@sskaparen.se

- 3.7 The fee includes:
 - boat, car, and trailer parking
 - one launching, one hauling
 - competition fee to Swedish Sailing Association with 10% of the entry fee but not more than 100 SEK per participant
 - the cost for the organizer
- 3.8 The whole entry fee will be paid back if cancellation is made before the closing date 12th of September 2020 except transaction fees e.g. costs to Svenska Seglarförbundet and Sailarena.



3.9 The entire entry fee, except bank related fees, will be refunded if the championship is cancelled due to too few participants – see point 2.5

4. Registration and measurement checks

- 4.1 Registrations shall be made at SSKa: s race office between 17.00 and 19.00 on Friday 18th September
- 4.2 Measurement certificates shall be presented at registration.
- 4.3 Competitor that is in charge onboard, according to 1.4 shall be able to present a valid license for competitor prior to racing, or be shown on the latest updated list for licenses 2020 on the homepage of Sailarena www.sailarena.com/sv/se/tavlingslicenser
- 4.4 A boat or equipment may be inspected at any time for compliance with the class rules and sailing instructions. On the water, the race- or/and the technical committee can instruct a boat to proceed immediately to a prescribed location for inspection.
- 4.5 Substitution of damaged or lost equipment will not be allowed unless approved by the race committee. Requests for substitution shall be made to the Race committee at the first reasonable opportunity.
- 4.6 A competitor may not be substituted without the written permission of the race committee.
- 4.7 Random measurement or secure checks may be done

5. SAILING INSTRUCTIONS

5.1 The supplementary sailing instructions will be handed out at registration.

- 6.2 No races will start after 15.00 on Sunday 20th.
- 6.3 7 races are scheduled

7. Race format

- 7.1 The regatta will be implemented as fleet racing in a straight series.
- 7.2 VHF can be used. The race committee will inform every start sequence or other information on channel 74*.
 - * Channel may be changed at competitors briefing
- 7.3 Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats. Race Committee will use VHF radio to communicate to all boats.

8.1 The racing areas will be on the Fiord of Kungsbacka

10. Protests and penalty systems

- 10.1 Amending RRS §44.1 and §44.2 changes the two-turn penalty ton one-turn penalty
- 10.2 The Swedish government and the Public Health Authority have issued rules and regulations in relation to the Corona pandemic. Competitors shall respect these rules and recommendations as directed by the Organizing Authority or Race Committee in either Notice of Race, Sailing Instructions or orally. A competitor or crew that does not comply with this rule, may be penalized by the Protest Committee as a discretionary penalty (DP). Rule 36 does not apply for a penalty under this rule.

11. Scoring

- 11.1 The low point scoring system of RRS Appendix A will apply, modified so that when three or fewer races have been completed; a boat's series score will be the total of her race scores.
- 11.2 A minimum of 3 races must be completed to constitute a Swedish Championship

12. Prizes

- 12.1 Championship plaquettes from Riksidrottsförbundet in gold, silver and bronze and titles may be awarded if six or more boats from at least three different Swedish clubs located in more than one Swedish district have crossed the finish line in one race in the championship.
- 12.2 SSKa prizes to 20 % of the participants
- 12.3 Possible sponsor prizes
- 12.4 Prizes from the Swedish Star boat Association

13. RIGHTS AND COPYRIGHT

13.1 In participating in this event, any competitor automatically grants to the Organising Authority, the Nationals and International Class Associations permission to make, use, and show, from time to time, any motion pictures and live, taped or film television and other reproductions of him/her during the period of the event without compensation.


We will not have the possibility to arrange any after-sail or regatta dinner, as the Swedish Health Ministry only allow us to gather with maximum 50 persons
